## ANNEXURE-II

1. The Vessel will be sold in "AS IS WHERE IS, WHAT IS THERE IS" basis.
2. The sale shall be free of all liens including Maritime lien and statutory liens, all encumbrances and other claims against the Said Vessel or her owner.
3. The sealed tender should be super scribed "TENDER FOR THE PURCHASE OF EVANGELIA M" and addressed to the Registrar (Judicial), High Court of Andhra Pradesh, Amaravati, delivered either in person or by registered post with acknowledgement due so as to reach him by 2.00 pm on 28<sup>th</sup> September, 2020. **The price should be quoted in US Dollars only.**
4. All the tenders received after the due date and time will be summarily rejected.
5. Telegraphic/telex/e-mail offers are not acceptable.
6. The intending bidders shall give their offer(s) in a sealed cover along with Earnest Money Deposit of \$41,852 (USD Forty one thousand eight hundred and fifty two only) by way of wire transfer (foreign inward remittance) to State Bank of India, Guntur Main Branch, Account Number 38969202369, Swift Code SBININBB181, Routing number SBIN0000844 (excluding bank charges) in favour of Registrar (Judicial), High Court of Andhra Pradesh.
7. No Bank Guarantees or cheques will be accepted.
8. The tenders sent without Earnest Money Deposit as mentioned above will be rejected summarily.
9. The tenders will be opened on 5<sup>th</sup> October, 2020 or on such adjourned date before the Hon'ble Judge sitting on the Original Side in the Admiralty Jurisdiction of the High Court of Andhra Pradesh, at Amaravati at 2.15pm and the acceptance of any tender will be at the sole discretion of the Court to get the best possible price.
10. All the bidders or the duly authorized representative of the bidder should be present in the Court on the date when the bids are opened.
11. The successful tenderer should pay the balance of bid amount on or before 19<sup>th</sup> October, 2020 in the same manner as in clause (6), i.e., by way of wire transfer (foreign inward remittance) to State Bank of India, Guntur Main Branch, Account Number 38969202369, Swift Code SBININBB181, Routing number SBIN0000844 (excluding bank charges).
12. On payment of the full sale consideration by the successful bidder, the Registry will issue the sale certificate to the successful bidder.
13. In default of payment of the amount referred to above within the time stipulated, unless otherwise extended the sale, will stand automatically revoked and the Earnest Money Deposit will be forfeited. Thereafter the other bidders will be given an opportunity to raise their bid amount to the highest bid already accepted, if they so desire. In the event several bidders come forward by raising their bid amount, the highest offer would be accepted. And in the event there is no such offer, the Vessel will be sold to the next highest bidder at the risk of the tenderer, whose tender was accepted, subject to order of the High Court.

15. The successful bidder shall take over the safety of the vessel within 24 hours of being declared the highest/successful bidder and payment of the entire sale consideration to be made into the Court.
16. All risks, costs, charges, fees and expenses of any kind involved in the removal of the vessel from her present position will be solely to the account of the successful purchaser
17. The Vessel should be removed from the KAKINADA PORT limits within fifteen days from the date of securing necessary permission from the Mercantile Marine Department and other authorities concerned, whichever is later, keeping the HARBOUR MASTER informed of developments and clear programme every week. During the said period, the Vessel should be kept manned by Certified Master, Officers and Engineers and adequate number of crew as required by the Mercantile Marine Department at the expense of the purchasers.
18. The buyer will have to pay all the Port charges and all other statutory dues to all Departments concerned from the date of confirmation of sale till date of actual removal of the Vessel from the Harbour.
19. Under no circumstances, the buyer will be permitted to break/dismantle the Vessel either in the Port of KAKINADA or in the KAKINADA HARBOUR.
